#### a. Staff

# Winnebago County (Carlos M.)

The trail is open, although some restoration work is still outstanding between Weldon-Meridian Roads. County staff will reinstall a brochure box at Meridian Road in addition to a box recently installed for the Village of Winnebago. DeGarmo trailhead is completed with the exception of minor punch list items. County staff will plow/salt the trailhead during the winter for patrons.

Commissioners also discussed the potential of an additional trailhead and additional poster size trail maps on aluminum sheets. Winnebago County Highway staff will get pricing and survey the commissioners to proceed.

#### **Stephenson County**

Stephenson County has received a project extension and plans to bid the project in March. The Project Development Report is still incomplete and right-of-way acquisition is still ongoing. City of Freeport is also looking to minimize changes in the path alignment to lessen costs not covered by the grant award.

# ComEd Bridge Issues

The Commission has not received a response to date from ComEd. Recent evidence of survey work was observed; and a follow up letter to ComEd to inquire as to their planned activities.

# b. Publicity/Marketing:

No recent activity. The Forest Preserves of Winnebago County has volunteered to keep tabs on matters regarding the domain name for the commission's internet presence.
